SUMMARY:

Additions, revocations and amendments are proposed necessitating permanent rulemaking action. The agency is considering proposals which are designed to make the administration of the Deferred Compensation Plan more efficient and member service oriented.

These rule changes allow for the implantation of a Roth plan for SoonerSave members. The amendments to 590:25-1-3 adds definitions to the new types of investment accounts available to participants. The amendment to 590:25-3-1 adds Roth Elective Deferrals as an election to defer compensation. The amendments to 590:25-3-3 addresses changes to Pre-Tax Elective Deferrals and Roth Elective Deferrals. The amendments to 590:25-5-8 addresses the deferrals to and earnings in Roth Elective Deferrals accounts and subaccounts. The amendment to 590:25-9-11 allows the participant to designate the source of distributions. The amendment to 590:25-9-15 addresses taxes and penalties related to distributions from the participants Roth Elective Deferral Subaccount. The amendments to 590:25-9-16 addresses the Plan accepting eligible rollovers from other eligible retirement plans.
