What is House Bill (HB) 1068?

- All deputy sheriffs and county jailer members are required to participate in the OPERS Hazardous Duty plan starting November 1, 2024.
- This allows employers to purchase prior service

Member Provisions

Contribution Rate
Retirement Eligibility
Computation Factor

Contribution Rate

- First 20 years: Contribute at the 8% hazardous duty rate.
- After 20 years: Contribute at the nonhazardous duty rate

Computation Factor

- During **whole** years: 2.5%, up to 20 years of hazardous duty service.
- All other service types and partial years of hazardous duty service: 2% nonhazardous duty rate:

Retirement Eligibility

- Retirement: after 20 full years of full-timeequivalent employment in the hazardous duty plan.
- Must retire from a hazardous duty eligible position to qualify under the 20-year rule.
- This eligibility option is in addition to the regular age and service requirements.

Example of Service

November 1, 2024

Non-hazardous Duty

Doesn't count toward 20-year rule

Calculated at 2%

Hazardous Duty

Counts toward 20-year rule
Calculated at 2.5%

Purchasing Prior Service

What is Purchasing Prior Service?

- County deputy sheriffs and jailers can purchase prior service credit at actuarial cost.
- This will convert your previous service as a county deputy sheriff or jailer to hazardous duty service.

Deadlines to Purchase Prior Service

- This is a limited time opportunity
- Must make the election to purchase by July 1, 2026
- Anyone who is not employed as a county deputy sheriff or jailer on November 1, 2024, but reemployed later:
 - Six months from rehire date

Why Purchase Service?

- Purchased service credit is calculated at 2.5%, instead of the normal 2.0% rate.
- Counts towards the 20-year rule you may be able to retire at a younger age.

Do You Have To Purchase Prior Service?



- You will still receive credit. for your prior service at 2.0%
- Only your Hazardous Duty service will be 2.5%.
 - Only your Hazardous Duty service will count toward the 20-year rule.

What is an Actuarial Purchase?

The amount required to fund an increase in future lifetime benefits you would receive.

- Considers
 - the loss of missed earnings for the time funds were not invested,
 - the member's age, and
 - current salary.

Example Costs – Example 1

- Current Age: 61
- Current Eligibility: 65
- Prior Service: 8 years
- Annual Salary: \$37,000

- Estimate cost: \$13,000
- New Eligibility: 65
- Benefit increase: 4% of final average salary

Example Costs – Example 2

- Current Age: 36
- Current Eligibility: 56
- Prior Service: 6 years
- Annual Salary: \$35,900

- Estimate cost: \$74,000
- New Eligibility: 50
- Eligible to start benefit 6 years sooner

How to start purchase

- Estimate your cost using online calculator.
- Complete Member Request for Service Credit Purchase form.
- 3. Your employer completes a Certification of Prior Service form.
- 4. OPERS works up file and confirms actual cost.
- 5. You will receive the costs and the *Election to Purchase*Service form

Ways to Pay for your Purchase

Ways to pay for your purchase:

- Check
- Qualified Rollover Plan
- Installment by Payroll Deduction

Additional Information and Resources

Step-Up Plan & Hazardous Duty Members

- Hazardous Duty members are not eligible to participate in Step-Up while contributing at the 8% hazardous duty rate.
- If you are in Step-Up, you will pause participating in Step-Up on November 1, 2024

Step-Up Plan & Hazardous Duty Members

After 20 years of Hazardous Duty service:

- If you previously were in Step-Up you must participate in Step-Up again.
- If you were not previously in Step-Up, you may not choose to participated.
