Shapes

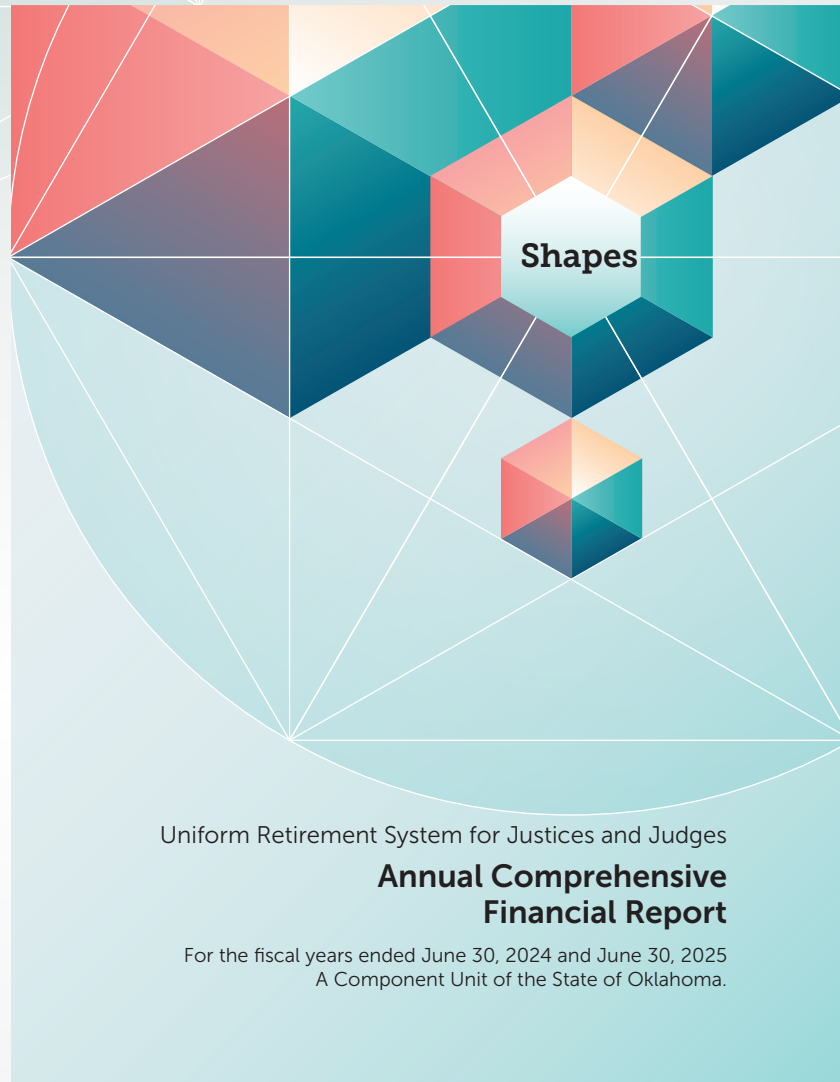
In our earliest years of childhood, we begin to recognize simple shapes: square, triangle and circle. As we grow, these forms take on dimension and purpose: cubes stack to build structures, pyramids provide enduring stability, and spheres roll to create motion.
